- 1. The candidates will have to deposit the fee in the shape of Demand Draft/RTGS/Credit/Debit Card to the allotted Institute directly as per the notified fees.
- 2. Final number of seats under each category shall be displayed on the admission web portal <u>https://nursing.online-counselling.co.in</u> before the start of counseling. The candidates should regularly visit these websites for updates.
- 3. Reservation and relaxation in age etc. shall be provided to the candidates as per State Reservation Policy.
- 4. Any candidate who fails to deposit original documents and the requisite fees to the Institute as per the time prescribed in the schedule will not be considered and his/her claim to admission will be forfeited.
- 5. Candidates registering them on the online portal should take care of it that they will deposit their fee only through UPI/Net Banking. Deposit of fees through Debit Card/Credit Card shall not be entertained and fees once deposited by way of any mode shall be Non-Refundable.

- 6. Before making admission institute must ensure that candidate is medically fit.
- 7. Admission shall be made to only those institutes which are recognized and approved for admission from INC/State Government/HN&NMC and as per Office Memorandum issued by INC vide no. 28-26/2017-INC dated 15.02.2019 wherever applicable. The institutes which are unable to get affiliation from HN&NMC shall not be considered for counseling.
- 8. The Institutes will have to mandatorily admit the candidates online on the admission web portal who have been allocated seats by the Council after document verification, failing which the candidature of the candidate will not be considered. The Institutes should ensure to complete the online process timely and No request regarding technical glitches/ oversightedness on online system will be entertained and concerned Institutes shall be solely responsible for the same.
- 9. Candidate should ensure to register on the admission web portal themselves only and fill all details like Name, Father/Mother Name, DOB, Category, Educational Qualification, Subject, Percentile, Address, Mobile No. and e-mail Id etc. carefully. No claim shall be entertained on this ground subsequently.
- 10. If any Institute fails to declare the vacancy position as per the specified date, such seats shall be considered filled and allotment to such seats shall not be made.
- 11. Under No circumstances, admissions shall be done after the last date of admission as notified.
- 12. Admissions shall be made strictly as per provisions contained in Notification dated 03-08-2022. In case of any lapse/fault on part of institution or candidate, the Council will not be responsible for the same and no claim shall be entertained later on.
- 13. Any orders of the Hon'ble Supreme Court/Punjab and Haryana High Court/ Other Courts/amendments by the State Government/Government of India, Ministry of Health & Family Welfare shall be applicable.
- 14. Council may display any other instructions as deem fit for making the admission in smooth way.
